Local Shared Care Templates and Searches on Clinical Systems

Local templates and searches on GP clinical systems for **shared care drugs** are now out of date. These will not be updated and new templates/searches will not be created for additional shared care drugs. **Locally created shared care templates and searches will no longer be available for use on GP clinical systems after the 30th April 2024**. Practices are advised to refer to the latest Shared Care Agreements hosted on the <u>LLR APC website</u> for current monitoring arrangements.

DOAC Guideline and Formulary Update

The <u>LLR Formulary</u> has recently been updated to reflect the recent patent expiry and significant price reduction of apixaban. Generic apixaban is now the First Choice DOAC in LLR for patients with non-valvular AF, unless there is a specific clinical reason not to do so.

<u>LLR Formulary Choice</u> The preferred DOAC should be chosen based on the current lowest acquisition cost. Given the dynamic nature of this information, please consult the LLR Formulary for the recommended choice. If the recommended option is not appropriate, clinicians should explore alternative DOACs in the sequence outlined in the formulary.

The LLR guidelines for <u>"Direct Oral Anti-Coagulants for Non-Valvular Atrial Fibrillation in Adults"</u> have also been updated and are accessible via the LLR APC website. The guidelines now refer the prescriber to the LLR Formulary for preferred choice of DOAC stating the above.

Medicines Safety Alerts

GP Practices have a contractual requirement to ensure they are receiving safety alerts and should ensure that they are signed up to receive all necessary alerts and that where appropriate, actions are completed as outlined by the <u>CQC</u>. The LLR Medicines Optimisation Team will circulate safety alert information where local recommendations or actions are required based on specialist advice. Practices should not rely on this newsletter to receive all safety alerts and can register to receive them via the <u>MHRA</u>. Medicines Supply Notifications (MSN) are sent directly to GP Practices via NHSE&I (please contact <u>england.gp-contracting@nhs.net</u> if you are not receiving these). Additional resources practices can sign up to include the MHRA <u>drug safety updates</u> and <u>drug safety newsletter</u> and the <u>Medicines Supply</u> <u>Tool</u>.

Sodium Valproate MHRA Alert: For Action by GP Practices

Following the <u>MHRA drug safety alert regarding prescribing valproate/ valproic acid</u>, the LLR designated a new group called the Sodium Valproate Task and Finish Group to coordinate the implementation of the new regulatory measures for new and existing patients younger than 55 years across the ICS on valproate or valproic acid. If a pharmacy is unable to obtain stock after following the <u>LLR APC Out-of-Stock-Guidance</u>, an acute prescription for an available equivalent product should be prescribed. Long term supply issues may require a review of the patient and a change to their medication. Please check with your local pharmacies for up-to-date information on stock availability.
