
Post Event Messaging PEM email to contractors - Deadline Thursday 31st October 2024

ALL community pharmacies **must check** on PharmOutcomes whether there are any unactioned PEMs. Some pharmacies have already completed this work in July as part of a Midlands trial – if this applies to your pharmacy, please still check your PharmOutcomes system for further unactioned PEMs.

It is essential that you complete this work as there are patient safety risks, if for example a high blood pressure reading has not been followed up. In addition, sending PEMs to patients' GP practices is a requirement in most pharmacy clinical service specifications.

Actions for Contractors, Pharmacists and Pharmacy Teams

- Read the attached letter, Annex 1 provides guidance on the priority order to review the clinical service notifications. *For example, Priority 1 is post event messaging relating to the blood pressure service.*
- Review and action the queue of notification emails within the PharmOutcomes system for the clinical services delivered by the pharmacy, in order of priority as set out in Annex 1.
- Follow instructions for manipulating the suppressed post event messages (PEMs) held within PharmOutcomes as set out in the supporting documentation; and follow guidance for sending notifications to a GP practice where suppressed PEMs need to be sent.
- If there are any concerns about potential patient harm because of delayed notifications following a pharmacy consultation, please report the incident using the <u>'Learning From Patient Safety Events'</u> portal and use the code <u>'PharmacyPEM</u>' for reporting purposes.
- Pharmacists must consider and fulfil their duty of candour.
- Return any locally agreed auditing report to confirm completion of actions. (Further information on this process will be provided shortly)



NATIONAL NEWS

Operational Guidance on Prison Releases

On 12 July 2024, the Ministry of Justice (MOJ) issued a <u>press notice</u> setting out how the government plans to tackle the prison capacity crisis due to operating at near full capacity. To help address this issue, a Statutory Instrument was laid before Parliament in order to make legislative changes to the percentage of time certain prisoners serving a Standard Determinate Sentence must spend in custody from 50% to 40%. This is being referred to as SDS40.

•Any FP10s issued from a prison on release are exempt from the prescription charge. For all subsequent NHS prescriptions issued in the community, usual exemption rules apply. See <u>here</u> for information on eligibility for free NHS prescriptions and <u>here</u> for help with health costs.

•For urgent medicines that have previously been prescribed as repeat prescriptions, released prisoners can access these by calling NHS 111. Please see also <u>Emergency prescriptions - NHS 111.</u>

•Pharmacy First Service

 Patients can access care for a specific range of conditions using the <u>Pharmacy First Service</u>, which enables them to get certain prescription medications directly from a pharmacy, without a GP appointment.
Healthcare professionals can use the <u>NHS Service Finder</u> to find pharmacies participating in this service and patient information is available <u>here</u>.
Patients can contact 111 or access <u>111 online</u> to be referred to a pharmacy that provides the full range of Pharmacy First services.

•NHS Pharmacy Contraception Service

oFor women being released from prison, the <u>NHS Pharmacy Contraception</u> <u>Service</u> provides an accessible and convenient place to receive advice and support for contraception management. This includes the supply of oral contraception that is exempt from prescription charges.

•Health and justice providers, as well as other healthcare professionals, can refer women to this service or they can refer themselves.

Individuals do not need to be registered with a GP to access this service.
Pharmacies will only inform the GP practice that individuals have accessed the service, with their consent.

Flu vaccination timings and payments

In line with Joint Committee on Vaccination and Immunisation (JCVI) recommendations, the flu letter sets out that pregnant women and children are to be offered flu vaccination from 1 September 2024 and that the other cohorts will follow from 3 October 2024. These recommendations are based on evidence that flu vaccine effectiveness can wane over time in adults.

No providers will be eligible for payment for the administration of influenza vaccinations outside the announced and authorised cohorts, with the limited exception of GPs that are able to evidence exceptional clinical circumstances requiring influenza vaccination to be administered at the request of the Commissioner.

NHS England launch the Community Pharmacy Technician Apprenticeship Programme

NHSE have annouced the launch of the Community Pharmacy Technician Apprenticeship Programme. This programme will support Pre-registration Trainee Pharmacy Technicians (PTPTs) to be employed and complete their full 24-month apprenticeship training within a **community pharmacy setting**. Upon completion of training and registration with the General Pharmaceutical Council (GPhC) this will support community pharmacy to utilise the expertise and knowledge of registered pharmacy technicians as part of pharmacy services and wider reform

Funding Offer

A training contribution of **£15,053 per trainee**, **per year for two years** (24 months) to support community pharmacies in developing a PTPT programme that meets the <u>GPhC IET standards for pharmacy technicians</u> and the <u>NHS</u> <u>England Quality Framework</u>.

Next Steps

Application for funding is through expression of interest (EoI) submitted via an <u>online application form</u>. The application window will open on Monday 23 September 2024 until Sunday 13 October 2024.
