Statutory Consultation – Pharmaceutical Needs Assessments (PNAs) for Leicester,

Leicestershire & Rutland

As you may know, PNAs are undertaken every three years to ensure that local community pharmacy services continue to meet the needs of the population. These assessments support NHS England and the Integrated Care Board (ICB) in making decisions about:

- Applications for new pharmacy premises
- Mergers and relocations
- Identification of service gaps or improvement areas

The Consultation Period is as follows:

- Opened: 9th June 2025
- Closes: 8th August 2025
- Duration: 60 days (statutory requirement)

How to Respond

You are formally invited to respond to the consultation. Please review at least one of the draft PNAs – for Leicester, Leicestershire, or Rutland – and complete the associated questionnaire.

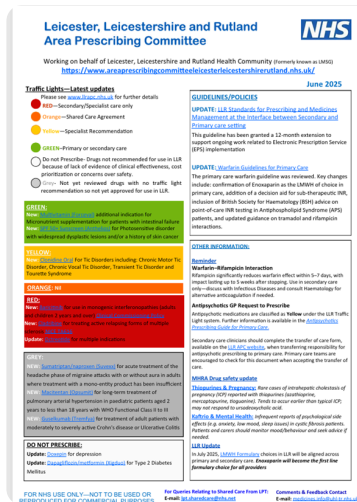
